The position offers the possibility for habilitation.

Your responsibilities will include:

- Leading research projects of the division
- Conceptualization, acquisition and implementation of third-party funded projects
- Teaching in the faculty's B.Sc. and M.Sc. programs
- Supervision of bachelor, master and doctoral students
- Participation in the committees of the university self-administration

Requirements are:

- MSc degree with very good or good results in agricultural science, veterinary medicine, food chemistry, or alike
- PhD in agricultural science, food chemistry, veterinary medicine or alike, preferably with a focus on product quality, completed with very good or good results
- Research experience in the field of livestock science, quality of animal products, sensory analysis and/or food analysis (especially chromatography, spectroscopy)
- (Initial) experience in university teaching and thesis supervision
- Good to very good command of written and spoken English and (desirable) good to very good command of German
- Confident handling of common MS office software
- Ability and willingness to perform statistical data analysis, ideally using R
- Experience in project management and funding acquisition is an advantage

Your strengths are ideally creativity, commitment and implementation strength, i.e. you are able to develop research goals and solution paths as well as implement them effectively. You are characterized by a quick grasp as well as a hands-on mentality, while working conscientiously and responsibly. You communicate convincingly and inspire people inside and outside the team to work with you.

The position offers the opportunity to develop and realize your own research focus in the profile of the division and thus to participate in socially relevant topics. Your further scientific qualification (habilitation) is desired and actively supported. This also includes the opportunity to participate in the certificate course in higher education didactics.

You will have access to the research infrastructure and laboratories of the department including the sensory lab of the Faculty of Agricultural Sciences. You will have a fair and secure job with flexible working hours including the possibility of mobile working. There is an option for an additional company pension (VBL) and you will receive various employee benefits. Lower Saxony also offers the possibility of educational leave (5d/calendar year).
